Protecting Tribal Citizens and Oklahoma Through Expanded Criminal Justice. Since 2020, the Choctaw Tribal Courts have filed over 3,500 felony and misdemeanor cases.



Judicial Officers: Choctaw Nation Tribal Court now employs three District Court Judges: two full-time Judges and one part-time Judge.



Expanded Tribal Prosecutor's Office: CNO now has **ten** Assistant Tribal Prosecutors to assist Lead Prosecutor Kara Bacon.



Expanded Public Defender's Office: CNO expanded the Public Defender's Office which now consists of one Public Defender Director and five Assistant Public Defenders.



Total Direct and Indirect Tribal funding spent on McGirt to date: \$28,974,778

Funding was allocated between Law Enforcement, Probation, Indian Child Welfare (ICW), Juvenile Services, Tribal Prosecution, Public Defenders, and Judicial/Tribal Courts.



Choctaw Tribal Police currently have 77 cross-deputization agreements with other local, state, and federal law enforcement agencies.
