WHEREAS, The Housing Authority of the Choctaw Nation of Oklahoma, the Tribally Designated Housing Entity (TDHE), has prepared and submitted the FY 2016 Indian Housing Plan (IHP) for approval; and


WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma must approve the FY 2016 IHP before it can be submitted to the U.S. Department of Housing and Urban Development for funding and implementation for the FY 2016 NAHASDA allocation to Indian Tribes


THEREFORE BE IT ENACTED BY THE Tribal Council of the Choctaw Nation of Oklahoma that the ACT be cited as approval of the attached FY 2016 IHP, to be submitted to the U.S. Department of Housing and Urban Development for approval and funding from the FY 2016 NAHASDA allocation to Indian Tribes



SECTION 8: IHP TRIBAL CERTIFICATION

NAHASDA § 102(c)

This certification is used when a Tribally Designated Housing Entity (TDHE) prepares the IHP or IHP amendment on behalf of the Tribe. This certification must be executed by the recognized tribal government covered under the IHP.

- (1) The recognized tribal government of the grant beneficiary certifies that:
- (2) It had an opportunity to review the IHP or IHP amendment and has authorized the submission of the IHP by the TDHE; or
- (3) It has delegated to such TDHE the authority to submit an IHP or IHP amendment on behalf of the Tribe without prior review by the Tribe.
