

TO APPROVE DISTRIBUTION OF A FORM TO ESTABLISH A LIST OF TRIBAL VOTERS OPEN TO TRIBAL
ELECTION CANDIDATES

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

THOMAS WILLISTON INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the distribution of a form that shall be used to establish a list of registered voters that will be released to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in tribal elections.

WHEREAS, the Choctaw Nation of Oklahoma has established a form to determine those tribal members who desire their name and address to be released to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in tribal elections; and

WHEREAS, an announcement shall be published in the February 2015 edition of the BISKINIK providing notice that a form will be mailed to registered voters during the month of March 2015 and such form will allow each responding member to designate whether such individual authorizes the Choctaw Nation of Oklahoma to release the voter's name and address to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in tribal elections; and

WHEREAS, the attached form (see page 3) shall be printed and mailed during the month of March 2015 to all registered voters of the Choctaw Nation of Oklahoma, such mailing shall also include a postage prepaid return envelope and notice that such form shall be return postmarked no later than April 30th, 2015; and

WHEREAS, all responses received postmarked on or before April 30th, 2015 shall be used to compile a list of registered voters responding in the positive, those who desire that their name and address be released as designated herein; and

WHEREAS, all responses received late, in the negative, or a failure to respond shall be documented by the Voter Registration department accordingly and such members shall not be included in the list of registered voters who desire their name and address be released to valid candidates running for an election position of the Choctaw nation of Oklahoma in tribal elections; and

WHEREAS, the Tribal Membership/Voters Registration application shall include a section allowing tribal members to designate whether such individual authorizes the Choctaw Nation of Oklahoma to release the voter's name and address to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in tribal elections; and

WHEREAS, any voter who desires to change their authorization shall do so by completing and executing a Tribal Membership/Voter Registration application indicating such; and

WHEREAS, the responses from the 2015 designation mailing shall be combined with ongoing responses collected via Tribal Membership/Voter Registration applications and used to continuously maintain a list of registered voters responding in the positive, those who desire that their name and address be released to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in the 2015 tribal election and future tribal elections; and


WHEREAS, such list shall be provided to the Election Board on the first day the Election Board opens office prior to each election.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Bill be cited as approval for distribution of a form to registered voters that will be used to establish a list of such voters that desire their name and address be distributed to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in tribal elections; and


BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Bill be cited as approval for the Election Board of the Choctaw Nation of Oklahoma to release a list containing the name and address of tribal members who selected to have their information released to valid candidates running for an elected position of the Choctaw Nation of Oklahoma in the 2015 tribal election and future tribal elections.

CERTIFICATION

I, the undersigned, as speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum. I further certify that (12) members answered roll call and that a quorum was present at the Regular Session of the Tribal Council at Tuskahoma, Oklahoma on February 14, 2015. I further certify that the foregoing Council Bill CB- 56 -15 was adopted at such meeting by the affirmative vote of twelve (12) members, zero (0) negative votes, and zero (0) abstaining.
