**TO APPROVE A LIMITED WAIVER
OF SOVEREIGN IMMUNITY
IN FAVOR OF STARBUCKS CORPORATION**

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE a limited waiver of sovereign immunity in favor of Starbucks Corporation

WHEREAS, the Choctaw Nation of Oklahoma (the “Nation”) is entering into a Master Licensing Agreement (the “Agreement”) with Starbucks Corporation and/or certain of its subsidiaries and affiliates (collectively, “Starbucks”);

WHEREAS, the Agreement contains a limited waiver of sovereign immunity from suit in favor of Starbucks as more particularly set forth in the terms of the Agreement;

WHEREAS, the Tribal Council of the Nation (the “Tribal Council”) has determined that it is in the best interest of the Nation to grant such a limited waiver of sovereign immunity in favor of Starbucks solely to the extent of, and in accordance with, the terms of the Agreement.

THEREFORE, BE IT ENACTED, by the Tribal Council that this Council Bill be cited as approval and authority for the grant of a limited waiver of the sovereign immunity of the Nation in accordance with the terms of the Agreement.

BE IT FURTHER ENACTED, by the Tribal Council that this Council Bill be cited as approval and authority that nothing contained herein is intended to, nor shall it be construed to, benefit any party other than Starbucks.


BE IT FURTHER ENACTED, by the Tribal Council that this Council Bill be cited as approval and authority that nothing contained herein is intended to, nor shall it be construed to, waive the sovereign immunity of the Nation or any of its affiliates or subsidiaries except as specifically set forth herein.

BE IT FURTHER ENACTED, by the Tribal Council that this Council Bill be cited as approval and authority that nothing contained herein is intended to, nor shall it be construed to, waive the sovereign immunity of any elected official, officer, or employee of the Nation or any of its affiliates or subsidiaries, and no waiver of immunity is provided with respect to such parties.
