RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget from the United States Institute of Museum and Library Services (IMLS) for the Native American Library Services (Basic Library) Grant.

WHEREAS, The Choctaw Nation of Oklahoma (the "Nation") has been awarded a grant by the United State Institute of Museum and Library Services (the "IMLS") for budget period August 1, 2019 through July 31, 2020 in the amount of \$10,000. See Exhibit 1;

WHEREAS, the IMLS grant will continue to support existing library operations and to maintain core library services at the Jones Academy;


WHEREAS, the total federal budget is \$10,000 with no required match; and


WHEREAS, funds from the Native American Library Services Grant will continue to provide a part-time librarian to Jones Academy and continue to keep the youth literature current.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept and approve the funds and the total budget of ten thousand dollars from the United States Institute of Museum and Library Sciences for the 2019 Native American Library Services (Basic Library) Grant for the budget period August 1, 2019 through July 31, 2020.
