RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE application to the United States Department of Health and Human Services, Indian Health Services for the 2020 Tribal Injury Prevention Cooperative Agreement.

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") realizes the need to design effective and innovative strategies in the prevention of injuries;


WHEREAS, funds from the United States Department of Health and Human Services, Indian Health Services will assist the Choctaw Nation in continuing its goal to educate Tribal Members on the prevention of motor vehicle and all-terrain vehicles (ATV) accidents through adoption of safe habits and the distribution of car seats to prevent critical or fatal injuries; and


WHEREAS, the Tribal Council finds it is in the best interest of the Nation to approve application to the 2020 Tribal Injury Prevention Cooperative Agreement.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Bill be cited as approval for application to the United States Department of Health and Human Services, Indian Health Services for the 2020 Tribal Injury Prevention Cooperative Agreement.
