

**TO APPROVE EXPANSION OF TRIBAL SERVICE AREA TO FIVE (5) COUNTIES IN TEXAS FOR THE PURPOSE OF HUD 184 LOANS**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the expansion of Choctaw Nation jurisdiction to service the counties of Grayson, Fannin, Lamar, Dallas, and Collin in the state of Texas for the purposes of HUD 184 loans.

**WHEREAS**, the Tribal Council (the "Council") of the Choctaw Nation of Oklahoma (the "Nation") has determined that it is in the best interest of the Nation to provide down payment and closing cost assistance mortgage loans in connection with the HUD 184 loan program to Tribal members located in Grayson, Fannin, Lamar, Dallas, and Collin counties in the state of Texas; and

**WHEREAS**, numerous Tribal employees and members reside the these areas: Grayson (1506), Fannin (253), Lamar (766), Dallas (2886), and Collin (1759) totaling 7,170 Tribal members that may benefit from this added service; and Tribal members should have the right to be fully eligible for HUD 184 services and should not be penalized due to location. Much of the current service area is high poverty and relocation to larger cities is necessary to offer greater opportunities for jobs, shopping, schools, and public transportation; and

**WHEREAS**, there are tribal businesses and industries located in these areas: see attached "Exhibit A"; and


**WHEREAS**, these proposed counties are connected or adjacent to the existing Choctaw Nation Servicing area; and


**THEREFORE BE IT ENACTED** by the Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for expansion of the Nation service area for HUD 184 loans.


**BE IT FURTHER ENACTED** by the Council that this service area expansion for the HUD 184 loan program is hereby approved, to allow HUD 184 loans be available in Grayson, Fannin, Lamar, Dallas, and Collin counties in the state of Texas.
