

TO APPROVE PURSUIT OF SUSTAINABILITY ACT

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

**TO APPROVE** the Pursuit of Sustainability Act, approving the renaming of the "Permanent Fund" to the "Sustainability Fund" and approving special contributions to the Sustainability Fund in the current balance as well as amounts transferred annually from the United States Department of the Interior - Office of the Special Trustee for American Indians (OST).

**WHEREAS**, the Nation wishes to rename the "Permanent Fund" to the "Sustainability Fund" to more accurately reflect its true intent and purpose; and

**WHEREAS**, the OST receives certain funds in trust for the Nation, including proceeds of trust assets and certain judgment funds; and

**WHEREAS**, the Nation's Tribal Council and Chief have adopted a Bill (CB \_\_\_ -18, THE TRUST FUND APPROPRIATION ACT) authorizing the transfer and use of all funds held by OST annually; and


**WHEREAS**, the Nation's Tribal Council and Chief recognize the sameness in purpose and goal between the Sustainability Fund and funds held by OST, which is the long-term sustainability of the Nation's essential services; and


**WHEREAS**, these special contributions are considered to be in addition to, and above, the normal contributions approved by the Revenue Allocation Policy (CB-136-15);


**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to rename the "Permeant Fund" to the "Sustainability Fund" and transfer all current & future OST balances to the Sustainability Fund.

**A COUNCIL BILL**

**WHEREAS**, the Tribal Council desires to assure that effective stewardship of the Tribal revenues is outlined each year based on the priority of general membership, and


**WHEREAS**, it is the intent of the Tribal Council to appropriate revenues each year based on a Revenue Allocation Plan which represents effective stewardship and yet another building block toward Tribal self-sufficiency, to ensure quality services and opportunities for future generations, and


**WHEREAS**, the Tribal Council desires amendments to the previously approved Revenue Allocation Plan, CB 85-14.


