

AMENDMENT TO CB-47-17

TO AMEND CB-47-17 TO CHANGE THE NAME OF THE LESSEE FROM JAMES ALEXANDER TO JESSE CHIP LOTT II AND DAVID CANTRELL ON GRAZING LEASE #4200070201 ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW & CHICKASAW NATIONS IN PITTSBURG COUNTY, OKLAHOMA

RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

**TO APPROVE** an amendment to CB-47-17 for Grazing Lease #4200070201 on land held by the USA in Trust for the Choctaw & Chickasaw Nations in Pittsburg County, Oklahoma.


**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

**WHEREAS,** the Amendment is to change the name of the lessee from James Alexander to Jesse Chip Lott II and David Cantrell on Grazing Lease #4200070201 on land held by the USA in Trust for the Choctaw & Chickasaw Nations. James Alexander was originally awarded the lease but he has since backed out and it will now be leased to Jesse Chip Lott II and David Cantrell in the amount of \$1,600.00 per year, in addition to doing brush and weed control on 120 open acres at a value of \$2,400.00 per year. Please see the attached revised lease labeled Exhibit "A". Also attached is a copy of CB-47-17 labeled Exhibit "B", and location map labeled Exhibit "C".



**TO APPROVE A GRAZING LEASE IN FAVOR OF JAMES ALEXANDER ON LAND USA IN TRUST FOR THE CHOCTAW AND CHICKASAW NATIONS IN PITTSBURG COUNTY, OKLAHOMA**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** a Grazing lease in favor of James Alexander, in Pittsburg County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


**WHEREAS,** James Alexander has proposed a grazing lease on land USA in Trust for the Choctaw & Chickasaw Nations located at the McAlester Watershed in Sections 23 and 26, all in Township 6 North, Range 14 East, Pittsburg County, Oklahoma, containing 253 acres, more or less (please see attached for complete legal description); and


**WHEREAS,** the lease will be for a term of three (3) years beginning on March 1, 2017, and expiring on February 28, 2020. Mr. Alexander has offered to pay annual rental in the amount of \$1,600.00. In addition to the rental, he has agreed to perform brush and weed control on 120 acres of open land at a value of approximately \$2,400.00 per year.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed grazing lease in favor of James Alexander on land USA in Trust for the Choctaw and Chickasaw Nations located in Pittsburg County, Oklahoma.


