

AMENDMENT TO CB-111-17

TO APPROVE AN AMENDMENT TO CB-111-17 TO INCLUDE A PROVISION THAT THE CHOCTAW NATION AGREES TO ACCEPT THE FULL THREE YEARS PAYMENT OF RENT UP FRONT IN LIEU OF COLLECTING A PERFORMANCE BOND FOR RECREATIONAL LEASE ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW & CHICKASAW NATIONS IN PITTSBURG COUNTY, OKLAHOMA

A COUNCIL BILL

TO APPROVE an Amendment to CB-111-17 for Recreational Lease in favor of Bill Black on land held by the USA in Trust for the Choctaw & Chickasaw Nations in Pittsburg County, Oklahoma.


WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


WHEREAS, Bill Black has proposed to pay the full three years rent as an alternate form of security to meet Bureau of Indian Affairs requirements for a performance bond for a Recreational Lease on Choctaw & Chickasaw Tribal Trust land located at the McAlester Watershed in Section 19, Township 6 North, Range 15 East, Pittsburg County, Oklahoma, containing 20 acres, more or less, more particularly described on the attached proposed lease labeled Exhibit "A". Also attached is a copy of CB-111-17 labeled Exhibit "B", and a location map labeled Exhibit "C".

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the Amendment to CB-111-17 for a Recreational Lease in favor of Bill Black, on land held USA in Trust for the Choctaw & Chickasaw Nations in Pittsburg County, Oklahoma.

TO APPROVE A RECREATIONAL LEASE IN FAVOR OF BILL BLACK ON LAND HELD USA IN TRUST FOR THE CHOCTAW & CHICKASAW NATIONS IN PITTSBURG COUNTY, OKLAHOMA

RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE a Recreational Lease in favor of Bill Black on land held USA in Trust for the Choctaw & Chickasaw Nations in Pittsburg County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


WHEREAS, Bill Black has proposed a recreational lease on land held USA in Trust for the Choctaw & Chickasaw Nations located at the McAlester Watershed in Section 19, Township 6 North, Range 15 East, Pittsburg County, Oklahoma, containing 20 acres, more or less, more particularly described on the proposed first page of the lease attached hereto as Exhibit A and as shown on the aerial map labeled Exhibit B; and

WHEREAS, the lease will be for a term of three (3) years and five (5) months beginning on August 1, 2017, and expiring on December 31, 2020. Mr. Black is offering to pay annual rental in the amount of \$150.00 and will control access in and out of the property. The rental for the third year of the lease will also include the additional 5 month time period therefore the rental that year will be \$212.50.




