

**TO APPROVE THE APPLICATION TO THE BUREAU OF INDIAN AFFAIRS FOR FEDERAL FUNDING TO REPLACE THE MUDDY BOGGY CREEK BRIDGE IN CHOCTAW COUNTY, OKLAHOMA.**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION OF OKLAHOMA**

**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the application to the Bureau of Indian Affairs Tribal Transportation Program Bridge Program (TTPBP) Funding to complete construction activities associated with the replacement of Muddy Boggy Creek, Bridge Number 00716.

**WHEREAS**, the Tribal Council is committed to protecting and preserving the interests of the tribal membership, and

**WHEREAS**, the Choctaw Nation of Oklahoma has a Tribal Transportation Program Agreement with the Bureau of Indian Affairs and is authorized to perform preliminary engineering, construction and associated activities on projects; and


**WHEREAS**, the Choctaw Nation of Oklahoma Transportation Program has identified Muddy Boggy Creek, Bridge Number 00716 in Choctaw County, Oklahoma, as a structurally deficient and functionally obsolete structure and a hazard to the travelling public; and


**WHEREAS**, the Choctaw Nation of Oklahoma Transportation Program desires to request Bureau of Indian Affairs TTPBP funds in the amount of One-million Dollars (\$1,000,000) for construction activities for the replacement of Muddy Boggy Creek, Bridge Number 00716.


**THEREFORE BE IT ENACTED**, by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill hereby authorizes the Chief to apply for Bureau of Indian Affairs Tribal Transportation Program Bridge Program (TTPBP) funding in the aforementioned amount and for the stated activities identified above.
