

TO APPROVE THE FY2018 BUDGETS FOR THE CHOCTAW NATION OF OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

**TO APPROVE** the Choctaw Nation of Oklahoma (the "Nation") Consolidated Tribal Government Programs (BIA) budget, the Jones Academy (BIE) budget and the Child Development Centers (CDC) Tribal Operating budget for the fiscal year beginning October 1, 2017 through September 30, 2018, in the amount of \$37,321,695.00.

**WHEREAS**, in accordance with Article IX, Section 8 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council of the Choctaw Nation of Oklahoma (the "Tribal Council") will approve the annual Tribal/Federal budget; and

**WHEREAS**, the Nation will operate all Federal budgets in accordance with 2CFR 200, U.S. Office of Management and Budget Super Circular; and


**WHEREAS**, the FY18 budgets are attached in Exhibit A, B and C, attached hereto and incorporated herein; and


**WHEREAS**, the Choctaw Nation of Oklahoma has compacted with the Bureau of Indian Affairs (BIA), Office of Self-Governance (OSG) and Bureau of Indian Education (BIE) for FY2018. The Tribal Council, Chief or his delegate shall have the authority to reallocate funds between the programs as deemed necessary and federally allowed throughout the fiscal year.


**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the Nation's BIA, BIE, and CDC FY/2018 budgets in the amount of \$37,321,695.00 under the conditions described within.

**CERTIFICATION**
