

**TO APPROVE A PIPELINE EASEMENT AND RIGHT OF WAY AGREEMENT ON CHOCTAW TRIBAL FEE LAND IN FAVOR OF ARKANSAS OKLAHOMA GAS CORPORATION, IN LEFLORE COUNTY, OKLAHOMA**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**  
**RONALD PERRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** a Pipeline Easement and Right of Way Agreement in favor of Arkansas Oklahoma Gas Corporation (AOG), in LeFlore County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


**WHEREAS,** AOG has proposed a ten foot (10') permanent easement and ten foot (10') temporary construction easement to provide gas service for the new Poteau Food Distribution Center. It will be located in part of the SE¼ NW¼ and NE¼ SW¼ of Section 3, Township 6 North, Range 25 East, LeFlore County, OK, more particularly described in the attached Exhibit "A". A copy of the proposed easement is attached and labeled Exhibit "B" and a location map is also attached and labeled Exhibit "C"; and


**WHEREAS,** there will not be any monetary consideration paid as this easement will be for the use and benefit of the Choctaw Nation of Oklahoma.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Pipeline Easement and Right of Way Agreement in favor of Arkansas Oklahoma Gas Corporation, on Choctaw Tribal Fee land in LeFlore County, Oklahoma.


**CERTIFICATION**
