

**TO APPROVE AN ELECTRIC LINE EASEMENT ON CHOCTAW TRIBAL FEE LAND IN FAVOR OF OKLAHOMA GAS AND ELECTRIC COMPANY, IN LEFLORE COUNTY, OKLAHOMA**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** an electric line easement in favor of Oklahoma Gas and Electric Company (OG&E), in LeFlore County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


**WHEREAS,** OG&E has proposed a ten foot (10') wide easement to provide electric service for the Poteau Health Care Pharmacy Refill Expansion project. It will be located in part of the W½ of Section 3, Township 6 North, Range 25 East, LeFlore County, OK, more particularly described on the attached easement labeled Exhibit "A". Also attached is a construction drawing labeled Exhibit "B"; and


**WHEREAS,** payment will be in the amount of \$10.00 as this easement will be for the use and benefit of the Choctaw Nation of Oklahoma. The easement will continue so long as the same is used or needed for the transmission and distribution of electric current or communication messages.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed electric line easement in favor of Oklahoma Gas & Electric Company, on Choctaw Tribal Fee land in LeFlore County, Oklahoma.


**CERTIFICATION**
