

TO APPROVE A FIBER OPTIC EASEMENT IN FAVOR OF OKLAHOMA WESTERN TELEPHONE COMPANY ON CHOCTAW TRIBAL FEE LAND IN PUSHMATAHA COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE a fiber optic easement in favor of Oklahoma Western Telephone Company (Oklahoma Western) on Choctaw Tribal fee land in Pushmataha County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, Oklahoma Western has proposed the fiber optic easement to provide service to the new Tuskahoma Facility Maintenance building located in part of the NW¼ NE¼ of Section 23, Township 2 North, Range 19 East, Pushmataha County, Oklahoma, more particularly described on the attached easement labeled Exhibit "A". Also attached is a copy of a detail map labeled Exhibit "B" and aerial map labeled Exhibit "C"; and

WHEREAS, there will be no monetary payment for this easement as it will be for the use and benefit of the Choctaw Nation of Oklahoma.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Fiber Optic Easement in favor of Oklahoma Western Telephone Company, on Choctaw Tribal fee land in Pushmataha County, Oklahoma.

CERTIFICATION

I, the undersigned, as Speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum.
