**RONALD PERRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** a Perpetual Highway Easement, in favor of the Oklahoma Department of Transportation (ODOT), in Bryan County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and;


**WHEREAS,** ODOT has proposed to construct and maintain a public highway and incidental utilities on Choctaw Tribal Fee land (Parcel 34) lying in part of the N½ NW¼ SE¼ of Section 13, Township 7 South, Range 8 East, Bryan County, Oklahoma, containing 0.13 acres, more or less, more particularly described on the attached Survey Plat labeled Exhibit "A"; and

**WHEREAS,** the easement will be for a perpetual term and the Choctaw Nation has agreed to donate the property to ODOT.


**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed perpetual highway easement in favor of the Oklahoma Department of Transportation, on Choctaw Tribal Fee land in Bryan County, Oklahoma.


**CERTIFICATION**
