

TO APPROVE THE CHOCTAW NATION OF OKLAHOMA AND STATE OF OKLAHOMA  
GAMING COMPACT NON-HOUSE-BANKED TABLE GAMES SUPPLEMENT

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the Choctaw Nation of Oklahoma and State of Oklahoma Gaming Compact Non-house Banked Table Games Supplement (the "Gaming Compact Supplement").

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") executed a gaming compact on November 24, 2004 (the "Gaming Compact") pursuant to the Indian Gaming Regulatory Act, 25 U.S.C. §2701 et seq. and the State-Tribal Gaming Act, 3A O.S. 280; and

WHEREAS, the existing Gaming Compact does not authorize operation of non-house-banked table games; and

WHEREAS, 3A O.S. §280.1, which will go into effect on August 2, 2018, authorizes the operation of non-house-banked table games by tribes with an existing gaming compact, if the tribes execute the Model Tribal Gaming Compact Supplement as set forth in 3A O.S. §280.1; and

WHEREAS, the Council acknowledges that the Gaming Compact Supplement is a technical amendment that amends and expands the definition of "[c]overed game" in the State-Tribal Gaming Act by removing the prior prohibition, and expressly authorizing the use of "table games involving a wheel, ball or dice" within the definition of "[n]on-house-banked table games"; and


WHEREAS, the Council has determined that executing the Gaming Compact Supplement is in the Nation's best interest.


THEREFORE BE IT ENACTED by the Council that this Bill be cited as approval of the Gaming Compact Supplement.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.

CERTIFICATION

I, the undersigned, as speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum. I further certify that twelve (12) members answered roll call and that a quorum was present at the Regular Session of the Tribal Council at Tuskahoma, Oklahoma on June 9, 2018. I further certify that the foregoing Council Bill CB-116-18 was adopted at such meeting by the affirmative vote of twelve (12) members, zero (0) negative votes, and zero (0) abstaining.
