

TO APPROVE OIL AND GAS LEASE NO. 4200082642 ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW NATION OF OKLAHOMA, IN FAVOR OF BRG PETROLEUM, LLC, IN LATIMER COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION
RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE an oil and gas lease in favor of BRG Petroleum, LLC (BRG), in Latimer County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


WHEREAS, BRG has proposed an oil and gas lease on land held by the USA in Trust for the Choctaw Nation described as Lot 9 (NE¼ SE¼), Lot 26 (NW¼ SE¼ SE¼), Lot 27 (NE¼ SE¼ SE¼), all part of Township Addition No. 5, in Section 6, Township 5 North, Range 19 East, Latimer County, OK, containing 60 acres, more or less. Please see attached lease labeled Exhibit "A" and location map labeled Exhibit "B"; and


WHEREAS, BRG submitted an acceptable bonus bid of \$7,560.00, but because it was below the appraised value, the bid was increased to \$15,000.00. The lease will be for a primary term of three (3) years with a \$3.00 per acre annual rental for a total of \$180.00, and a royalty rate of 18.75 percent.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Oil and Gas Lease No. 4200082642, in favor of BRG Petroleum, LLC, on land held by the USA in Trust for the Choctaw Nation in Latimer County, Oklahoma.
