IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE application to the United States Department of Health and Human Services (HHS) Indian Health Service (IHS) Tribal Management Grant (TMG) Program in the amount of Three Hundred Thousand Dollars (\$300,000).

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") realizes the need to enhance and develop health management infrastructure to further develop and improve management capability;


WHEREAS, IHS funds will be used by the Nation to develop programs and organizational structures that will promote revenue enhancement, organizational growth, and accountability; and

WHEREAS, the Tribal Council has determined it is in the best interest of the Nation to approve application for the TMG Program to HHS and IHS.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to apply to the United States Department of Health and Human Services and Indian Health Service for the Tribal Management Grant Program.
