TO APPROVE THE FUNDS AND BUDGET FOR YEAR FIVE OF FIVE CONTINUATION FOR THE NATIONAL WORKFORCE DIVERSITY PIPELINE PROGRAM (PATHS)

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget for the United States Department of Health and Human Services (“HHS”) for the Year Five of Five Continuation for the National Workforce Diversity Pipeline Program (“PATHS”).

WHEREAS, the Tribal Council approved the application for PATHS in CB-76-15, funds and budget for Year One in CB-15-16, application for Year Two Continuation in CB-83-16, funds and budget for Year Two in CB-156-16, funds and budget for Year Three in CB-132-17, funds and budget for Year Four in CB-48-19;

WHEREAS, the Choctaw Nation (the “Nation”) has been awarded a grant by HHS for budget period August 1, 2019 to July 31, 2020 to increase the racial and ethnic diversity in the health care and behavioral health professions;


WHEREAS, the total federal budget is \$485,000 with no required match; and

WHEREAS, funds for PATHS will assist the Nation in identifying students in their first year of high school and providing them with a foundation to pursue successful careers in the health profession by increasing the availability of science technology engineering and mathematics (“STEM”) education programs.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept and approve the funds and budget from the United States Department of Health and Human Services Year Five of Five Continuation for the National Workforce Diversity Pipeline Program.

CERTIFICATION
