A COUNCIL BILL

**TO APPROVE** a Service Line Agreement in favor of Dobson Technologies (Dobson), in Latimer County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


**WHEREAS,** Dobson has proposed a Service Line Agreement for fiber service for the new Talihina Travel Plaza on land held by the USA in Trust for the Choctaw & Chickasaw Nations described as being in the SE¼ of Section 3, Township 3 North, Range 21 East, Latimer County, OK, see attached drawing labeled Exhibit A and Agreement labeled Exhibit B; and


**WHEREAS,** there will be no monetary compensation since it will be for the use and benefit of the Choctaw Nation.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Service Line Agreement in favor of Dobson Technologies on land held by the USA in Trust for the Choctaw & Chickasaw Nations in Latimer County, Oklahoma.


CERTIFICATION
