

TO RESCIND CB 136-15, CB 85-14, CB 107-12, AND ALL OTHER ENACTMENTS PERTAINING TO REQUIRED METHODOLOGY OR PROCEDURE FOR ALLOCATION OF TRIBAL FUNDS

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO RESCIND CB 136-15 titled, "To Amend the Choctaw Nation Revenue Allocation Plan," to rescind CB 85-14 titled, "To Amend the Choctaw Nation Revenue Allocation Plan," to rescind CB 107-12 titled, "To Approve the Choctaw Nation Revenue Allocation Policy," and to rescind all other Tribal Council legislation, rules or regulations (together "Enactments") pertaining to required methodology or procedure for allocation of tribal funds; and

WHEREAS, copies of CB 136-15, CB 85-14, and CB 107-12 with accompanying Revenue Allocation Plans are attached hereto; and

WHEREAS, the Council has determined that it is in the best interest of the Nation to rescind all versions of the Choctaw Nation Revenue Allocation Plan and all other Enactments pertaining to required methodology or procedure for allocation of tribal funds.

THEREFORE BE IT ENACTED by the Council that CB 136-15, CB 85-14, CB 107-12, and all other Enactments pertaining to required methodology or procedure for allocation of tribal funds, are hereby rescinded.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.

CERTIFICATION

I, the undersigned, as speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum. I further certify that twelve (12) members answered roll call and that a quorum was present at the Regular Session of the Tribal Council at Tuskahoma, Oklahoma on August, 11 2018. I further certify that the foregoing Council Bill CB-142 -18 was adopted at such meeting by the affirmative vote of twelve (12) members, zero (0) negative votes, and zero (0) abstaining.
