

TO APPROVE THE FY2020 BUDGETS FOR THE INDIAN CHILD WELFARE PROGRAM AND TO APPROVE THE FAMILY PRESERVATION PROGRAM

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED A COUNCIL BILL

A COUNCIL BILL

TO APPROVE the proposed budget for the Choctaw Nation Indian Child Welfare Program as funded by Title IV-B Subpart I for FY2020 with the required tribal match.

TO APPROVE the proposed budget for the Choctaw Nation Family Preservation Program as funded by Title IV-B Subpart II for FY 2020 with the required tribal match.

WHEREAS, the grant award under Title IV-B Subpart I for the Indian Child Welfare Program is \$533,492.00 with an in-kind tribal match of \$177,830.67;

WHEREAS, the grant award under Title IV-B Subpart II for the Family Preservation Program is \$867,044.00 with an in-kind tribal match of \$289,015.00; and


WHEREAS, these budgets are for the fiscal year beginning October 1, 2019 through September 30, 2020 has been made in accordance with the amount of the USDA adjusted grant for the previous year (FY2019).

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for the Choctaw Nation Indian Child Welfare Program Title IV-B Subpart I budget of five hundred thirty-three thousand four hundred ninety-two dollars for FY2020 from the United States Department of Health & Human Services, and the required in-kind tribal match of one hundred seventy-seven thousand eight hundred thirty dollars and sixty-seven cents.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for the Choctaw Nation Family Preservation Program Title IV-B Subpart II budget of eight hundred sixty-seven thousand forty-four dollars for FY2020 from the United States Department of Health & Human Services, and the required in-kind tribal match of two hundred eighty-nine thousand fifteen dollars.



CERTIFICATION
