

TO APPROVE A COUNCIL BILL ADOPTING THE CHOCTAW NATION CHILDREN'S CODE

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE a Council Bill adopting certain codes for use in the Court of General Jurisdiction of the Choctaw Nation of Oklahoma.

WHEREAS, this Council created the Court of General Jurisdiction of the Choctaw Nation of Oklahoma with CB-65-2009 and amended thereto with CB-60-16 on the 16<sup>th</sup> day of February, 2016; and

WHEREAS, the new Court system was approved by the U.S. Department of Interior on October 8, 2009; and

WHEREAS, in accordance with CB-65-2009 and CB-60-16, the new Court was activated and the CFR Court of Indian Offenses of the Choctaw Nation was abolished by the Chief on February 4, 2010; and


WHEREAS, the Court of General Jurisdiction has provided for adoption by this Council certain Judicial Codes, which replaced all or a portion of the Rules for the CFR Court of Indian Offenses of the Choctaw Nation; and


WHEREAS, this Children's Code of the Choctaw Nation of Oklahoma, shall rescind and replace the Choctaw Nation of Oklahoma Children's Code as enacted on the 13<sup>th</sup> day of November, 2012, via Council Bill CB-25-13.


THEREFORE BE IT ENACTED, by the Tribal Council of the Choctaw Nation of Oklahoma, that this Bill be cited as rescission of CB-25-13, and the code attached thereto, and approval of the adoption of the Children's Code of the Choctaw Nation of Oklahoma, as attached, under the condition described herein.

CERTIFICATION
