A COUNCIL BILL

TO APPROVE application to the United States Department of Housing and Urban Development (HUD) for the Tribal HUD-Veterans Administration Supportive Housing (VASH) Grant.


WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") realizes the need to provide subsidized rental assistance for Native American Veterans who are at-risk of or currently experiencing homelessness;

WHEREAS, funds from the United States Department of Housing and Urban Development (HUD) will help the Nation assist Native veterans by providing rental vouchers for those confirmed to be eligible by the Veterans Administration (VA);


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Bill be cited as approval for application to the United States Department of Housing and Urban Development (HUD) for the Tribal HUD-Veterans Administration Supportive Housing Grant.
