A COUNCIL BILL

TO APPROVE the funds and budget for the Choctaw Nation Seniors Farmers' Market Nutrition Program for Fiscal Year for the amount of \$31,746.

WHEREAS, the Seniors Farmers' Market Nutrition Program (SFMNP) provides low-income seniors with access to locally grown fruits, vegetables, honey and herbs;

WHEREAS, the SFMNP helps to increase consumption of agricultural commodities through farmers' markets, roadside stands, and community supported agricultural programs.;


WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") has been awarded Thirty-One Thousand Seven Hundred Forty Six Dollars (\$31,746) from the United States Department of Agriculture (USDA) for the SFMNP;

WHEREAS, this proposed budget is for the fiscal year beginning October 1, 2018 through September 30, 2019.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma, that this bill be cited as approval to accept Thirty-One Thousand Seven Hundred Forty Six Dollars (\$31,746) from the United States Department of Agriculture and approve the budget for the Senior Farmers' Market Nutrition Program for FY19.
