RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

**TO AMEND** Council Bill CB-34-20, A Council Bill Authorizing the Chief to Place Property In Pittsburg County in Trust Status with the United States of America, by the Choctaw Nation of Oklahoma (the "Nation") desires to amend the proposed use of the property for this acquisition of land into trust status with the United States of America.

**WHEREAS**, in CB-34-20, the Tribal Council of the Choctaw Nation of Oklahoma (the "Council") approved the following: "**BE IT FURTHER ENACTED** by the Tribal Council of that this Bill be cited as approval that the property's use, which is improved with a gravel parking area for the nearby clinic, will not be changed and while the remainder of the property is vacant and undeveloped land to which there will be no change to the usage." **WHEREAS**, since the passage of CB-34-20, the Choctaw Nation of Oklahoma (the "Nation") now seeks to amend the purpose of the property for the acquisition of land into trust status;

**WHEREAS**, the Council finds it is in the best interest of the Nation to amend CB-34-20 by striking certain language indicating there will be no change to the land use and inserting language that the land will be used for a medical clinic expansion and development.


**THEREFORE, BE IT ENACTED**, by the Tribal Council of the Choctaw Nation of Oklahoma, that this Bill be cited as approval to amend CB-34-20 as by striking "~~BE IT FURTHER ENACTED by the Tribal Council of that this Bill be cited as approval that the property's use, which is improved with a gravel parking area for the nearby clinic, will not be changed and while the remainder of the property is vacant and undeveloped land to which there will be no change to the usage.~~" and inserting "BE IT FURTHER ENACTED by the Tribal Council that this Bill be cited as approval that the property's use, which is improved with a gravel parking area for the nearby clinic and the remainder being vacant and undeveloped, will be used for a medical clinic expansion and development that accommodates increases in medical services to Tribal citizens. The Nation has a commitment to promote healthy living and improving the quality of life of Tribal citizens."


**BE IT FURTHER ENACTED** by the Tribal Council that the above amendment be effective immediately.

**TO AMEND CB-34-20, A COUNCIL BILL  
AUTHORIZING THE CHIEF TO PLACE PROPERTY IN PITTSBURG COUNTY IN TRUST STATUS

**Purpose/Need of Council Bill:** This bill amends CB-34-20, a bill that proposed placing 13.02 acres of real property located in McAlester, Pittsburg County, Oklahoma in to trust. See Exhibit A. CB-34-20 stated that the purpose of the property would be unchanged. The Nation seeks to amend the bill by changing language that states that the property will be used for a medical clinic expansion and development for which will accommodate increase in medical services to Tribal citizens.
