RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE a Council Bill adopting the Choctaw Nation of Oklahoma Codification Authorization Act.

WHEREAS, the statutory law of the Choctaw Nation of Oklahoma (the "Nation") consists of original enactments adopted by the Tribal Council of the Choctaw Nation of Oklahoma (the "Council");

WHEREAS, the Council realizes the need to compile, arrange, and publish all statutory laws of the Nation adopted pursuant to the Constitution for accessibility, transparency, and convenience for all; and


WHEREAS, the Council finds it is in the best interest of the Nation to adopt the Choctaw Nation of Oklahoma Codification Authorization Act, also known as the "Codification Authorization Act", pursuant to Exhibit A as attached.

THEREFORE BE IT ENACTED, by the Tribal Council of the Choctaw Nation of Oklahoma, that this Bill be cited as approval to adopt the Choctaw Nation of Oklahoma Codification Authorization Act, pursuant to Exhibit A as attached.

BE IT FURTHER ENACTED, by the Tribal Council of the Choctaw Nation of Oklahoma that the Choctaw Nation of Oklahoma Codification Authorization Act shall be effective immediately.
