

**TO APPROVE AN OIL & GAS LEASE IN FAVOR OF BRAVO ARKOMA (BRAVO), LLC, ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW & CHICKASAW NATIONS IN ATOKA COUNTY, OKLAHOMA**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION  
RONALD PERRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** an Oil & Gas Lease in favor of Bravo Arkoma (Bravo), LLC, on land held by the USA in Trust for the Choctaw & Chickasaw Nations in Atoka County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and


**WHEREAS,** Bravo has proposed an oil & gas lease on land held by the USA in Trust for the Choctaw & Chickasaw Nations described as an undivided ½ mineral interest in the NE¼ of Section 12, Township 2 North, Range 13 East, Atoka County, Oklahoma, containing 160 acres, more or less, the proposed lease is attached hereto labeled Exhibit A and the property is as shown on the aerial map labeled Exhibit B; and


**WHEREAS,** Bravo has submitted an acceptable bonus bid of \$307.25. The lease will be for a primary term of three (3) years with a \$3.00 per acre annual rental for a total of \$240.00 and a royalty rate of 18.75%.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Oil & Gas Lease in favor of Bravo on land held by the USA in Trust for the Choctaw & Chickasaw Nations in Atoka County, Oklahoma.

**CERTIFICATION**
