

TO APPROVE AN UNDERGROUND ELECTRIC EASEMENT ON CHOCTAW TRIBAL FEE LAND  
IN FAVOR OF PUBLIC SERVICE COMPANY OF OKLAHOMA, IN PUSHMATAHA COUNTY,  
OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

**TO APPROVE** an Underground Electric Easement in favor of Public Service Company of Oklahoma (PSO), in Pushmataha County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

**WHEREAS,** PSO has proposed this easement for the Antlers Elder Housing project. It will be located in the SW¼ SW¼ SW¼ and the W½ SE¼ SW¼ SW¼ of Section 4, Township 4 South, Range 16 East, Pushmataha County, Oklahoma, more particularly described on the attached proposed easement labeled Exhibit "B" and attachment thereto labeled Exhibit "A". Also attached is a location map labeled Exhibit "C"; and


**WHEREAS,** The easement will be for a perpetual term for and in consideration of the sum of \$1.00 and other good and valuable consideration. This easement will be for the benefit of the Choctaw Nation of Oklahoma.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Easement in favor of PSO, on Choctaw Tribal Fee land in Pushmataha County, Oklahoma.

**CERTIFICATION**
