

AMENDMENT TO CB-124-16

TO AMEND CB-124-16 TO CORRECT THE NUMBER OF RODS CONTAINED IN RIGHT OF WAY NO. T-150 (RENEWAL OF T-44 AND M-1731) IN FAVOR OF ONEOK GAS TRANSPORTATION, LLC, ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW & CHICKASAW NATIONS IN LATIMER COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE the amendment to CB-124-16 for Right of Way No. T-150 in favor of ONEOK Gas Transportation, LLC (ONEOK) on land held by the USA in Trust for the Choctaw & Chickasaw Nations in Latimer County, Oklahoma.


WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, the Amendment is to correct the number of rods contained in the legal description for Right of Way No. T-150 in favor of ONEOK on land held by the USA in Trust for the Choctaw & Chickasaw Nations. The revised Centerline description states it is a **total distance of 1562.89 feet or 94.72 rods**, more or less, as opposed to the previously stated distance of 1490 feet or 90.30 rods, more or less. Please see the attached revised survey labeled Exhibit "A". Also attached is a copy of CB-124-16 labeled Exhibit "B", previous survey labeled Exhibit "C", and location map labeled Exhibit "D".


