

**TO APPROVE A GRAZING LEASE ON CHOCTAW TRIBAL FEE LAND IN FAVOR OF MONTY RICHARDS, IN MCCURTAIN COUNTY, OKLAHOMA**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** a Grazing Lease in favor of Monty Richards in McCurtain County, Oklahoma.

**WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

**WHEREAS,** Monty Richards has proposed a lease on Choctaw Tribal fee land located near the Broken Bow casino in part of Section 25, Township 6 South, Range 24 East, McCurtain County, Oklahoma, containing 18.38 acres, more or less, more particularly described on the attached proposed lease labeled Exhibit "A". Also attached is a location map labeled Exhibit "B"; and

**WHEREAS,** the lease will be for a term of three (3) years at an annual rental rate of \$250.00. In addition to the rental payment, Mr. Richards has also agreed to practice weed, sprout, and brush control on 18 acres of open land valued at \$360.00 per year.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed Grazing Lease in favor of Monty Richards, on Choctaw Tribal Fee land in McCurtain County, Oklahoma.

**CERTIFICATION**
