IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget from the United States Department of Justice for the Coordinated Tribal Assistance Solicitations (CTAS) Purpose Area #1 –Community Policing Services (COPS) Tribal Resources Hiring and Equipment/Training Grant.

WHEREAS, the Choctaw Nation (the “Nation”) has been awarded a grant by Department of Justice (DOJ) for budget period September 1, 2019 through August 31, 2022 in the amount of \$505,345 to provide Tribal law enforcement with equipment and training for safer communities. see Exhibit A;


WHEREAS, the total project budget is \$505,345 with no required match; and

WHEREAS, funds from DOJ will allow the Nation to purchase training, vehicles and equipment needed to provide effective and thorough community policing within the Choctaw Nation.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept five hundred five thousand three hundred forty-five dollars (\$505,345) from the United States Department of Justice for Coordinated Tribal Assistance Solicitation Purpose Area #1 – Community Policing Services Tribal Resources Hiring and Equipment/Training Grant for the budget period September 1, 2019 through August 31, 2022.
