TO APPROVE the funds and budget from the State of Oklahoma District Attorneys Council for the Victims of Crime Act (VOCA) Grant.

WHEREAS, the Choctaw Nation (the "Nation") has been awarded the Victims for Crime Act (VOCA) Grant (the "VOCA Grant") by the State of Oklahoma District Attorneys Council for budget period October 1, 2019 through September 30, 2020 to continue to expand and enhance victims of crime services;

WHEREAS, the total project budget is \$153,315 with no required match;

WHEREAS, funds for the VOCA Grant will assist the Nation in serving underserved Native American victims of elder/vulnerable adult abuse through case management, advocacy, intervention services, transportation, accompaniment, emergency services, safety planning and implementation, child/dependent care coordination, restitution advocacy, court advocacy, and other emergency services; and

WHEREAS, the Tribal Council of the Choctaw Nation finds it is in the best interest of the Nation to approve the VOCA Grant award of \$153,315 and approve the budget for the VOCA Grant as stated in Exhibit 1.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept one hundred fifty three thousand three hundred fifteen dollars from the State of Oklahoma District Attorneys Council for the Victims of Crime Act Grant for the budget period October 1, 2019 through September 30, 2020.

BE IT FURTHER ENACTED, by the Tribal Council that this Bill be cited as approval of the budget for the Victims of Crim Act Grant and approve the budget as stated in Exhibit 1 of this Bill.
