**A COUNCIL BILL**

**TO RESCIND CB-135-01**, a Council Bill Approving a Motor Fuel Tax Fund Expense For Choctaw Nation Boys & Girls Club.

**WHEREAS**, on June 12, 2001, the Tribal Council (the "Council") and the Chief of the Choctaw Nation of Oklahoma (the "Nation") enacted CB-135-01, a council bill allocating Twenty-Five Thousand Dollars (\$25,000) annually to the Boys and Girls Club of Broken Bow and the Boys and Girls Club of Tahihina, Oklahoma for a total donation of Fifty Thousand Dollars (\$50,000). **WHEREAS**, the Council now wishes to rescind CB -135-01, with donations to be based on Donations Committee guidelines.


**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that CB-135-01 is hereby rescinded.

**WHEREAS**, the youth are the future leaders of the Choctaw Nation, and


