#### CB - 85 – 20 AMENDMENT

TO AMEND COUNCIL BILL CB-85-20, A COUNCIL BILL ENTITLED: "TO APPROVE APPLICATION FOR THE INDIAN COMMUNITY DEVELOPMENT BLOCK GRANT (ICDBG) – CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT (CARES)"

#### IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

### RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

#### A COUNCIL BILL

**TO AMEND CB-85-20**, a Council Bill approving application to the United States Department of Housing and Urban Development for the Indian Community Development Block Grant—Coronavirus Aid, Relief and Economic Security Act.

WHEREAS, on June 13, 2020, the Tribal Council of the Choctaw Nation (the "Council") passed CB-85-20, a Council Bill approving application to the United States Department of Housing and Urban Development (HUD) for the Indian Community Development Block Grant (ICDBG)-Coronavirus Aid, Relief and Economic Security Act (CARES Act). See Exhibit 1.

WHEREAS, the CB-85-20 allowed the Choctaw Nation of Oklahoma (the "Nation") to apply for up to \$3,000,000 with no required match to pursue ICDBG-CARES Act funding that will prevent, prepare for, and respond to COVID-19 by developing 10 Independent Elder Units and Infrastructure which is an identified community need and directly responds to all eligible purposes of the funding announcement;

**WHEREAS**, HUD officials have since requested that the Council certify that the following HUD requirements were met and that Council Bill CB-85-20 be amended to include the following language:

#### "Citizen Participation Certification

The Choctaw Nation of Oklahoma hereby certifies that the citizen participation requirements identified in 24 CFR 1003.604(a) and Notice PIH 2020-11 have been met for the ICDBG-CARES project(s) that is/are being proposed.

- a) The proposed project was disclosed on May 28, 2020 to the public in the local newspaper of the project site, Durant Democrat;
- b) The proposed project was also posted to the website of the Choctaw Nation of Oklahoma;
- c) Responses and comments were welcomed attention: Choctaw Nation of Oklahoma, Grants Development Office; and
- d) No responses to date have been received from the general public regarding the proposed project."

**WHEREAS**, HUD requested that Council certify that the Citizen Participation requirements were met before any funding is awarded to the Nation.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to amend CB-85-20 and insert the following language:

### "Citizen Participation Certification

The Choctaw Nation of Oklahoma hereby certifies that the citizen participation requirements identified in 24 CFR 1003.604(a) and Notice PIH 2020-11 have been met for the ICDBG-CARES project(s) that is/are being proposed.

a) The proposed project was disclosed on May 28, 2020 to the public in the local newspaper of the project site, Durant Democrat:

**BE IT FURTHER ENACTED** by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
