

TO APPROVE THE PROPOSED FY19 BUDGET FOR JONES ACADEMY

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the proposed Jones Academy budget for the fiscal year beginning October 1, 2018 through September 30, 2019, in the total amount of \$8,718,470.

WHEREAS, in accordance with Article IX, Section 8 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council of the Choctaw Nation of Oklahoma (the "Council") will approve the annual tribal budget;

WHEREAS, Jones Academy operates as a Bureau of Indian Education ("BIE") elementary school under the authority of the Nation;

WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") has entered into a compact with the BIE for FY19 to operate Jones Academy;

WHEREAS, the BIE has awarded the Nation \$8,637,470 to be used for Jones Academy for FY19. See Exhibit A;

WHEREAS, the Nation supplements the Jones Academy budget with \$81,000 from various sources. See Exhibit A; and

WHEREAS, the Council finds it is in the best interest to approve the proposed budget for FY19 for Jones Academy.


HEREFORE BE IT ENACTED by the Council that this Bill be cited as approval to accept \$8,637,470 from the Bureau of Indian Education to be used for the proposed FY19 budget for Jones Academy.

BE IT FURTHER ENACTED by the Council that this Bill be cited as approval of \$81,000 of supplemental funds to be used for the proposed FY19 budget for Jones Academy.



CERTIFICATION


