A COUNCIL BILL

TO APPROVE application to the United States Department of Health and Human Services, Indian Health Service Tribal Management Grant in the amount of \$300,000.


WHEREAS, the Choctaw Nation of Oklahoma (the "Nation") realizes the need to enhance and develop health management infrastructure to further develop and improve management capability; and

WHEREAS, funds awarded by Indian Health Services will be used to develop programs and organizational structures that will promote revenue enhancement, organizational growth, and accountability;


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval for application to the United States Department of Health and Human Services, Indian Health Service for the Tribal Management Grant in the amount of three hundred thousand dollars.

CERTIFICATION
