RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION

A COUNCIL RESOLUTION

TO APPROVE a Resolution reappointing the Bob Rabon to the Appellate Division of the Choctaw Nation of Oklahoma Court Tribal Courts.

WHEREAS, Section 1.104 of the Act Establishing A Court of General Jurisdiction For The Choctaw Nation of Oklahoma (the "Act") states that "The Appellate division and District Court Judges shall be appointed by the Chief and confirmed by the Tribal Council." See CB-65-2009;

WHEREAS, in accordance with the Act, judges shall be appointed for four-year terms and the terms shall be staggered;


WHEREAS, pursuant to the Act, the Chief of the Choctaw Nation of Oklahoma has selected Bob Rabon for reappointment to the Appellate Division of the Choctaw Nation of Oklahoma Tribal Court; and

WHEREAS, the Tribal Council finds it is in the best interest of the Choctaw Nation of Oklahoma to confirm the reappointment of Bob Rabon to the Appellate Division or the Tribal Court of the Choctaw Nation for a term of four years.


THEREFORE BE IT RESOLVED by the Council that this Resolution be cited as approval to confirm the reappointment of Bob Rabon to the Appellate Division of the Choctaw Nation Tribal Court for a term of four years expiring on January 9, 2025.
