Vendor Requirements & Information

Dear Vendor Applicant:

In order to comply with the tribal/state gaming compact and to ensure the integrity of our gaming operation, the Choctaw Nation Gaming Commission will require vendors to obtain a Vendor's Gaming License in order to do business with Choctaw Nation Casino(s).

During the licensing process, the Choctaw Nation Gaming Commission will conduct an in-depth investigation of your business's background, as well as the person(s) associated with your business. If the investigation reveals no derogatory information and all licensing requirements are met, your business will be issued a vendor gaming license. This will allow you to conduct business with Choctaw Nation Casinos for a period of 2 years from the date of approval. The issuing of a vendor's license does not guarantee an exclusive or contractual right to furnish goods and/or services to any Choctaw Nation gaming facility.

The Vendor Business License Application is available from the Gaming Commission office. You can find the Vendor License/Permit Application for individuals, along with additional supporting documents on our website for you to complete and return to our office. The original of each completed form, and any requested information, should be returned within 30 days. A non-refundable application fee must also accompany the original application documents when they are submitted.

Vendor Licensing Fee Structure

GAMING VENDORS

Gaming Machine Vendors	License Fee
Gaming machine vendors with 1 to 25 licensed employees	\$5,000.00
Gaming machine vendors with 26 to 50 licensed employees	\$7,500.00
Gaming machine vendors with 51 to 100 licensed employees	\$10,000.00
Gaming machine vendors with 101 to 150 licensed employees	\$15,000.00
Each additional employee over limit will require an application fee of \$250.00.	

GAMING-RELATED VENDORS

(Fee structure revised effective 01/01/2013)

Gaming-Related Vendors	License Fee
Vendors paid \$25,000.00 & above yearly with 1-10 licensed employees	\$1,000.00
Vendors paid \$25,000.00 and above yearly with 11-25 licensed employees	\$2,500.00
Each additional employees over limit will require an application fee of \$250.00	

VENDOR PERMIT

Vendor Employee/Representative	Permit Fee
Vendor employee/representative of a non-gaming related vendor issued a visitor's badge more than 5 times within a month	\$50.00/employee/representative Vendor License/Permit Application must be completed with the Choctaw Nation Gaming Commission

Choctaw Gaming Commission vendor licenses are valid for a period of 2 years.

New vendors will have fees determined by estimating future payments.
