RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget for the United States Department of Justice for the Transitional Housing Assistance Grants for Victims of Sexual Assault, Domestic Violence, Dating Violence, and Stalking Program – Project HOUSE.

WHEREAS, the Choctaw Nation has been awarded a grant by the United States Department of Justice for budget period October 1, 2016 to September 30, 2019 in the amount of \$349,956 to assist in providing individuals fleeing domestic violence, dating violence, stalking, or sexual assault with safe housing and support services; and


WHEREAS, the total federal budget is \$349,956 with no required match; and

WHEREAS, funds for the Transitional Housing Assistance Grants for Victims of Sexual Assault, Domestic Violence, Dating Violence, and Stalking Program from the United States Department of Justice will assist the Choctaw Nation in helping victims locate and secure permanent housing and provide activities to move victims along the continuum of care.



CERTIFICATION


