IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the funds and budget for the United States Department of Justice for the Cops Tribal Resources Equipment/Training Grant.

WHEREAS, the Choctaw Nation has been awarded a grant by the United States Department of Justice for budget period September 1, 2016 to August 31, 2019 in the amount of \$975,933 to continue a coordinated approach by providing Choctaw Nation Tribal law enforcement with equipment and training for safer communities; and


WHEREAS, the total federal budget is \$975,933 with no required match; and

WHEREAS, funds for the Cops Tribal Resources Equipment/Training Grant from the United States Department of Justice will assist the Choctaw Nation by allowing for the purchase of equipment and vehicles needed to provide effective and thorough community policing in the 10 ½ counties of the Choctaw Nation.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept and approve the funds and budget for the United States Department of Justice for the Cops Tribal Resources Equipment/Training Grant.

CERTIFICATION
