

**TO APPROVE THE FUNDS AND BUDGET FOR THE NATIVE YOUTH INITIATIVE FOR LEADERSHIP, EMPOWERMENT, AND DEVELOPMENT GRANT**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the funds and budget for the United States Department of Health and Human Services for the Native Youth Initiative for Leadership, Empowerment, and Development Grant.

**WHEREAS**, the Choctaw Nation has been awarded a grant by the United States Department of Health and Human Services for budget period September 30, 2016 to September 29, 2017 in the amount of \$299,491 to assist in supporting local community projects that foster Native youth resiliency; and


**WHEREAS**, the total federal budget is \$299,491 with a required \$74,933 match of tribal funds; and


**WHEREAS**, funds for the Native Youth Initiative for Leadership, Empowerment, and Development Grant from the United States Department of Health and Human Services and the tribal funds will assist the Choctaw Nation in providing after school tutoring, life skill lessons, and summer camp to at-risk high school youth in Choctaw, McCurtain, and Pushmataha Counties.


**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to accept and approve the funds and budget for the United States Department of Health and Human Services for the Native Youth Initiative for Leadership, Empowerment, and Development Grant.
