

TO APPROVE A GRAZING LEASE IN FAVOR OF DUSTIN MORGAN ON CHOCTAW TRIBAL FEE LAND IN MCCURTAIN COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION  
RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL


- TO APPROVE** a Grazing lease in favor of Dustin Morgan, in McCurtain County, Oklahoma, at Sharp's Landing.
- WHEREAS,** in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and
- WHEREAS,** Dustin Morgan has proposed a grazing lease on Choctaw Tribal Fee land at Sharp's landing located West of Hwy 37 in Lot 5 of Section 8, Township 8 South, Range 22 East, McCurtain County, Oklahoma, containing 55 acres, more or less; and
- WHEREAS,** the lease will be for a term of three (3) years beginning on December 15, 2016, and expiring on December 14, 2019. Mr. Morgan has offered to pay annual rental in the amount of \$1,000.00. In addition to the rental, he has agreed to perform brush and weed control on 50 acres of open land at a value of approximately \$1,000.00 per year.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed grazing lease in favor of Dustin Morgan on Choctaw Tribal Fee land located in McCurtain County, Oklahoma.

CERTIFICATION
