A COUNCIL BILL

TO APPROVE the disposal of vehicles, furniture, fixtures or equipment with an original cost of \$59,895.00 and a net book value of \$17,071.62 including all listed inventory, as attached.


WHEREAS, the Choctaw Nation of Oklahoma has surplus inventory items that need to be disposed, and

WHEREAS, the Choctaw Nation Fixed Assets Department desires to dispose of said excess equipment in the most cost effective manner possible, with the net proceeds from any sale being returned to the program, as stated on the attachment, when applicable.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approved for the Fixed Assets Department to dispose of excess equipment under the conditions described herein.
