A COUNCIL BILL


TO APPROVE the use of General Fund to provide Eyeglasses, Dentures/Partials, Hearing Aids and Durable Medical Equipment.


WHEREAS, EDH Program Services will be provided by these funds for Eyeglasses, Dentures/Partials, Hearing Aids and Durable Medical Equipment to Choctaw Nation of Oklahoma Tribal Members. All Choctaw Nation of Oklahoma Tribal Members will be considered eligible for the program. All Funds will be used for direct services, there will be no administrative cost.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval to spend \$2,800,000.00 each year for Eyeglasses, Dentures/Partials, Hearing Aids and Durable Medical Equipment and which supersede all previous Council Bills.

CERTIFICATION

Eight (8) members must be present to constitute a quorum. Charley Jones INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE the Use of General Fund to Provide Eyeglasses, Dentures, and Hearing Aids

WHEREAS, the Chief will appoint a committee of three people to screen and to make determinations on applicants under the age of 55, and


WHEREAS, EDH Program services will be provided by these funds for Eyeglasses, Dentures, and Hearing-aids to Choctaws. Only Choctaws living within the boundaries of the Choctaw Nation will be considered eligible for the program. All funds will be used for direct services with the exception of administrative cost which will include postage, office supplies, and travel. The administrative costs will not exceed \$10,000.


BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval to expend \$200,000 each year, for the next three years, for Eyeglasses, Dentures, and Hearing Aids.
