

TO APPROVE A GRAZING LEASE IN FAVOR OF JAMES ALEXANDER ON LAND USA IN TRUST FOR THE CHOCTAW AND CHICKASAW NATIONS IN PITTSBURG COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE a Grazing lease in favor of James Alexander, in Pittsburg County, Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, James Alexander has proposed a grazing lease on land USA in Trust for the Choctaw & Chickasaw Nations located at the McAlester Watershed in Sections 23 and 26, all in Township 6 North, Range 14 East, Pittsburg County, Oklahoma, containing 253 acres, more or less (please see attached for complete legal description); and


WHEREAS, the lease will be for a term of three (3) years beginning on March 1, 2017, and expiring on February 28, 2020. Mr. Alexander has offered to pay annual rental in the amount of \$1,600.00. In addition to the rental, he has agreed to perform brush and weed control on 120 acres of open land at a value of approximately \$2,400.00 per year.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval of the proposed grazing lease in favor of James Alexander on land USA in Trust for the Choctaw and Chickasaw Nations located in Pittsburg County, Oklahoma.

CERTIFICATION

I, the undersigned, as Speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum. 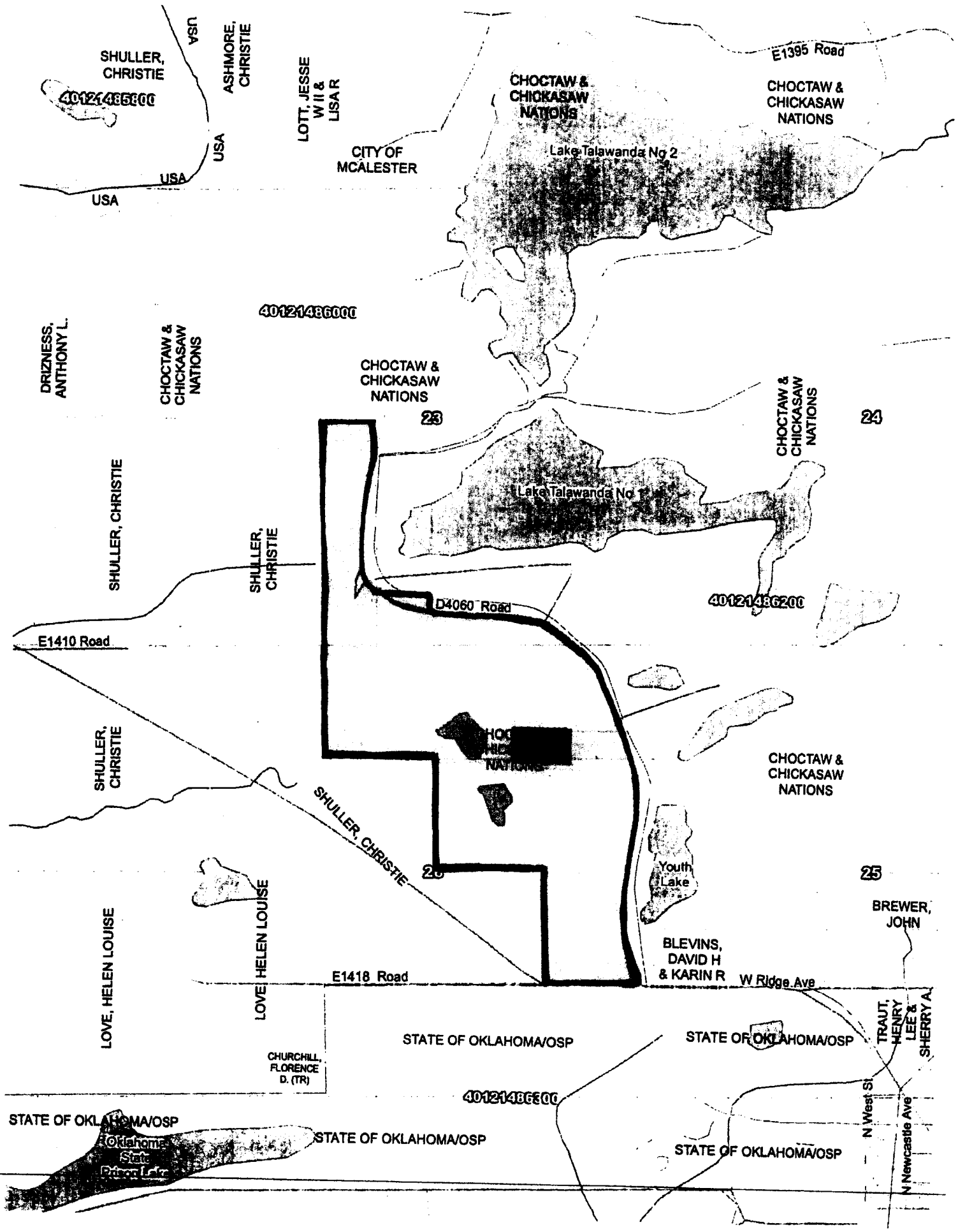
