

TO APPROVE A DONATION CERTIFICATE FOR EASEMENTS FOR PUBLIC HIGHWAY (PARCELS # 1.0, 2.0, 2.1) TO THE COUNTY OF PITTSBURG ON CHOCTAW TRIBAL FEE LAND IN PITTSBURG COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

ANTHONY DILLARD INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE a Donation Certificate for Easements for Public Highway (Parcel # 1.0, 2.0, 2.1) to the County of Pittsburg, State of Oklahoma.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, the County of Pittsburg has proposed a Donation Certificate for Easements for Public Highway (Parcel # 1.0, 2.0, 2.1) on Choctaw Tribal Fee land whereby the Choctaw Nation agrees to waive the appraisal process and elect to donate the easements on parcel 1.0, 2.0, and 2.1. The lands are all located in the SW¼ NW¼ of Section 22, Township 2 North, Range 15 East, Pittsburg County, OK, (please see attached easements for full legal descriptions); and

WHEREAS, the Easements on Parcels # 1.0 and 2.0 will be for perpetual terms and the Easement on Parcel #2.1 will be for a temporary term.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval of the proposed Donation Certificate to the County of Pittsburg, State of Oklahoma, on Choctaw Tribal Fee land located in Pittsburg County, Oklahoma.

CERTIFICATION

I, the undersigned, as Speaker of the Tribal Council of the Choctaw Nation of Oklahoma, do hereby certify that the Tribal Council is composed of twelve (12) seats. Eight (8) members must be present to constitute a quorum. I further certify that eleven (11) members answered roll call and that a quorum was present at the Regular Session of the Tribal Council at Tuskahoma, Oklahoma, on February 13, 2016. I further certify that the foregoing Council Bill CB- 53 -16 was adopted at such meeting by the affirmative vote of eleven (11) members, zero (0) negative votes, and zero (0) abstaining.
