

TO APPROVE GRAZING LEASE NO. G09-1881 IN FAVOR OF STEVEN W. CHURCH ON LAND USA IN TRUST FOR THE CHOCTAW NATION OF OKLAHOMA, IN LATIMER COUNTY, OKLAHOMA

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

ANTHONY DILLARD INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE Grazing Lease No. G09-1881 with Steven W. Church, in Latimer County, OK.

WHEREAS, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation, and

WHEREAS, Steven W. Church has proposed a Grazing Lease on land USA in Trust for the Choctaw Nation of Oklahoma described as Lots 3 and 4; and the S½ NW¼ of Section 4, Township 5 North, Range 19 East, Latimer County, OK, containing 160.95 acres, more or less; and

WHEREAS, the lease will be for a term of three (3) years beginning January 1, 2016, and expiring December 31, 2018. He will pay annual rental in the amount of \$900.00. In addition to the rental payment, Mr. Church has agreed to do brush and weed control each year on 20 acres of open land by brush hog or chemical spray at a value of \$400.00 per year.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval of proposed Grazing Lease No. G09-1881 with Steven W. Church on land USA in Trust for the Choctaw Nation of Oklahoma located in Latimer County, Oklahoma.

CERTIFICATION
