TO APPROVE THE NAHASDA 2017 INDIAN HOUSING PLAN (IHP).


WHEREAS, The Housing Authority of the Choctaw Nation of Oklahoma, the Tribally Designated Housing Entity (TDHE), has prepared and submitted the FY 2017 Indian Housing Plan (IHP) for approval; and


WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma must approve the FY 2017 IHP before it can be submitted to the U.S. Department of Housing and Urban Development for funding and implementation for the FY 2017 NAHASDA allocation to Indian Tribes.


THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that the ACT be cited as approval of the attached FY 2017 IHP, to be submitted to the U.S. Department of Housing and Urban Development for approval and funding from the FY 2017 NAHASDA allocation to Indian Tribes.
